As the world observes Safer Internet Day today on Tuesday 7 February 2023, the National Ainformation Communications Technology Authority (NICTA) calls for a safer online experience for everyone including children and young people. The aim of Safer Internet Day is to promote the use of technology in a responsible, respectful, critical, and creative way, resulting in a safer and improved internet experience for all.

Let us always be mindful of the inherent risks such as hacking, phishing scams, and identity theft, as well as the spread of misinformation and exposure to inappropriate or harmful content. Online supervision and monitoring of children should be a priority for parents to ensure their safety when online. And lastly, encourage your children to come to you if they encounter anything online that makes them uncomfortable or if they need help handling a difficult situation.

Consistent with Governments Digital Safety policy and to ensure the safety of citizens including children while using the internet, various measures by the NICTA in collaboration with PNG Safer Internet Committee have been implemented, such as supporting public awareness campaigns to educate citizens about online risks and how to stay safe, providing resources and support for individuals and families to protect themselves from online harm and partnering with stakeholders to address online safety issues. It is essential that we increase our efforts to create a digital agenda that empowers and keeps safe our children.

It is the responsibility of all individuals to contribute to a positive online experience. This can be achieved by being considerate and respectful towards others, actively seeking out opportunities to create and connect in a positive way. Additionally, it is crucial to take action against negative online behavior by reporting any illegal or inappropriate content.

The COVID-19 pandemic has reinforced the idea that having access to digital and online platforms is no longer a luxury, but a necessity for everyone. Bridging the gap between those who have access to the internet and those who don't is a top priority for the NICTA. Bridging the gap for internet access is important because it can help to promote social and economic development, improve access to education and healthcare, and create opportunities for those who may otherwise be excluded from the digital economy.
