

# Public Consultation Discussion Paper Proposed variations to the Licence Conditions Rule 2011

# 1 EXECUTIVE SUMMARY

The *National Information and Communications Technology Act 2009 (the Act)* at Section 55 provides for NICTA to "make rules setting out the standard terms and conditions, and any special terms and conditions, for individual licences."

The current rules, which appear on NICTA's website at <a href="https://www.nicta.gov.pg/licensing/terms-conditions">https://www.nicta.gov.pg/licensing/terms-conditions</a>, were developed in 2011 and have not been changed since then.

The draft proposed revised Rules are annexed at Attachment A.

#### The main revisions are:

- (1) To remove terms and conditions that no longer apply, such as the obligations previously imposed on Telikom in relation to the operation of the National Maritime Safety radio service, or which are no longer appropriate in the circumstances of 2023, such as the obligation to print a hard copy telephone directory annually;
- (2) To make provision for the inclusion of Low Earth Orbit (LEO) satellite services and related conditions;
- (3) To include special terms and conditions relating to Digitec Communications (trading as Vodafone) similar to those already included in relation to Digicel and Telikom;
- (4) To update the lists of locations relevant to coverage obligations; and
- (5) To make provision for coverage obligations that reflect the current circumstances of each of the individual licensees concerned and clear milestones for achievement of 100% coverage of each geographic area or location by a nominated date.

# 2 PROPOSED RULE VARIATIONS

# 2.1 Comments on specific matters

#### LEO satellite services

On 14 August 2023 NICTA initiated a public consultation on the Licensing Condition Rules that should apply for Low Earth Orbit (LEO) satellite services in PNG. The deadline for submissions in response to the LEO satellite service consultation paper is 11 September 2023. The paper may be found on NICTA's website at https://www.nicta.gov.pg/cp-0-29/

NICTA determined to seek the views of stakeholders and other interested parties to the proposed terms and conditions for LEO satellite services ahead of the general review of licence terms and conditions, because of the need to provide the earliest certainty to parties interested in providing LEO satellite services in PNG. Many of the services that have been advised to NICTA are clearly in the overall public interest, especially in areas that are not well served at present with ICT services, and delay in clarifying the terms and conditions needs to be avoided or at least reduced.

The proposed licence terms and conditions set out at Schedule 3A of the proposed Rule are the same as the draft subject to public consultation from August 2023. Interested stakeholders and other potential respondents need to have provided their comments on these conditions by 11 September 2023 and need not repeat them in response to the current Public Consultation Discussion Paper.

# **Printed Telephone Directory services**

Under the current Rules, which were established in 2011, the former Telikom (PNG) Limited was required to publish in hard copy a telephone directory of relevant telephone service numbers annually to provide information for those wishing to call the subscribers in question.

Times have changed significantly over the 12 years since the Rule was established. In common with the rest of the world, PNG has experienced the mobile revolution, with cellular mobile calling being the preferred means of making voice calls to other subscribers. Importantly, cellular mobile service numbers have never been included in the numbers that Telikom was required to include in its printed telephone directory. The use of telephone directories as a source of numbers has been in decline around the world for many years. In part this may be because mobile numbers are not comprehensively listed. It is also because of the availability of other number sources, and particularly of the internet for obtaining contact information for businesses and government.

The proposal to remove the obligation on Telikom as a licence term condition to print a hard copy telephone directory at least every two years leaves it open for Telikom to do so if it considers that it is in its commercial interests to do so. If Telikom proceeds on that basis it will need to obtain the consent of the subscribers whose details are published.

NICTA does not have specific questions that submissions might address in relation to each section of the draft Rule. In relation to each and all sections of the draft Rule the issues to be considered are:

- (1) Is each of the existing terms and conditions and the proposed variation (if any) appropriate in the circumstances of the ICT in PNG in 2023, and if so why, or if not, why not?
- (2) Could the obligations covered by the terms and conditions be better expressed, having regard to the objects of the Act?
- (3) Are there additional terms and conditions that should be considered in relation to any category of licence, and if so, what are they and why should they be added?

Respondents are requested to identify the part of the draft Rule they are referring to in their comments, including the schedule and paragraph number if applicable.
